PEER COUNSELING AND ENGINEERING RESEARCH: ABLEGAMERS PEER COUNSELING PROGRAM CONSISTS OF PLAYERS WITH DISABILITIES AND OCCUPATIONAL PROFESSIONALS WHO WORK TOGETHER TO FIND THE BEST SOLUTIONS FOR PEOPLE WITH DISABILITIES TO ENABLE PLAY. PEER COUNSELING SESSIONS ARE A STARTING POINT FOR GRANTING THE HARDWARE, CUSTOM CONTROLLERS, AND SPECIALIZED EQUIPMENT/TECHNOLOGIES THAT CAN BE PROHIBITIVELY EXPENSIVE. THE ABLEGAMERS ENGINEERING RESEARCH PROGRAM COMPLIMENTS THE PEER COUNSELING PROGRAM BY PROTOTYPING AND CREATING NEW CONTROLLERS AND DEVICES, OFFERING UNIQUE AND CUSTOMIZED SOLUTIONS FOR PLAYERS WHEN BARRIERS TO CURRENT COMMERCIALY AVAILABLE PRODUCTS EXIST.
